### Chapter Award Descriptions

---

All nominations must be submitted via the Award Nomination form. EOE status does not determine eligibility to be nominated for an award, although your EOE status may be considered.

When writing your nominations, include tangibles or examples of how your chapter has exemplified that award. The same goes for the individual nominations. Thinking about the specific examples that could help with better understanding why you are making that nomination. The reviewers are not affiliated with the University of Connecticut and need concrete examples to adequately score nominations.

#### Chapter of the Year

This award is designed to recognize the chapters that have demonstrated excellence in all endeavors and represent the highest qualities of fraternity and sorority life as related to the shared pillars of citizenship, leadership, and scholarship. This chapter has gone above and beyond to exemplify the values that we encourage as a community and does so with sincere compassion for the greater good. For this award there will be one winner from each council.

The Advisors in the Center of Fraternity and Sorority Development will review and consider coaching, academics and chapter's overall progress in choosing the 4 winners of the Chapter of the Year award.

#### Excellence in Academic Achievement

We support the academic vision and mission of the University and fully engage in the relationship between academic and co-curricular activities. It is the chapter's goal to encourage scholastic standards and policies to support their members in their academic success so that they can lead successful lives in which they contribute to both their fields of interest and broader society in a positive way. This award is designed to recognize chapters with a high GPA and chapters that have held programming specifically for academics within their general members and/or new members.

### **Excellence in Member Development**

We are committed to the growth and development of fraternity and sorority members by ensuring that the programming efforts reflect individual needs throughout their entire membership in the chapter and aim to foster new members that will have a positive impact on the community. Your new member education program should not only prepare individuals for active membership in the chapter, but also in the fraternity/sorority community and beyond. This award is designed to recognize a chapter who has focused on programming or efforts to further the development of their members by educating them on an array of subjects that also have importance outside of the fraternity & sorority community.

### **Excellence in Recruitment & Retention**

Community members should recruit with the intention of building a sustainable chapter of members who share similar principles and reflect the values of their fraternity/sorority. To ensure the future success of their organization, the organization ensures that members are prepared to take on the responsibilities that come with upholding their membership and values. Chapters are conscious of their size and their intake frequency to meet the requirements set by inter/national organization, local governing council, and the University. This award is designed to recognize chapters that have put intentional and conscious effort into their recruitment while focusing on the overall growth of their organization, regardless of new member count.

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

### **Excellence in Chapter Operations**

Chapters effectively and productively run all chapter meetings, programs, and events. They maintain productive relationships with their on-campus advisor, CFSD coach, and alumni advisor that help chapter operations run smoothly. They have policies and/or practices in place to ensure a thorough transition of officers and maintain an updated constitution and/or bylaws. Chapter creates a budget and calendar that align with their organization's values. They improve chapter operations to provide a positive experience for their members. This award recognizes a chapter that has implemented specific practices that allow them to better operate as an organization whether that be for meetings, programs, or events.

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

**Excellence in Community Impact**

Chapters support and provide opportunities for their members to be global citizens and exemplify a commitment to create meaningful impact in the Storrs and greater Connecticut community through intentional and innovative philanthropic and service initiatives. Not only does the organization encourage members' involvement in university-sponsored outreach programs, but the organization also strives to support the organization's national philanthropies. From the UConn Academic Vision: "Through outreach and partnerships, we promote sustainable development and a happy, healthy, and inclusive society. This engagement is local and global, based on intercultural understanding and recognition of the transnational nature of the challenges and opportunities we face." This award recognizes a chapter that embodies the quote above through innovative and unique philanthropic and service initiatives.

**Excellence in Diversity & Inclusion**

This award recognizes a chapter that demonstrates an ongoing and holistic commitment to diversity, equity, inclusion, and belonging across all areas of chapter operations. The chapter intentionally fosters an environment where members feel empowered to express and celebrate their identities, whether related to race, ethnicity, gender identity, sexual orientation, religion, socioeconomic background, ability, or other dimensions of diversity—while also encouraging learning about and respecting the experiences of others. Through their actions, programs, and culture, members uphold a standard of civility, inclusion, and respect, and actively work to create a community that is equitable and culturally aware. This chapter not only prioritizes education and dialogue around issues that affect marginalized communities but also takes action to challenge injustice and create more inclusive systems both within and beyond their organization.

**Excellence in Public Relations and Marketing**

This award recognizes a chapter that excels in using public relations, branding, and marketing to promote both their organization and the broader fraternity and sorority community in a positive and values-based way. The chapter demonstrates intentional efforts to shape public perception by showcasing the impact, leadership, service, and inclusivity of its members through strategic communication.

The chapter actively works to enhance its image through a variety of platforms, including social media, campus publications, websites, in-person outreach, and community partnerships. Through these efforts, they help tell the story of modern fraternity and sorority life—one rooted in purpose, connection, and meaningful contribution.

This chapter also understands the importance of relationship-building and serves as a strong ambassador between the fraternity/sorority community, the campus community, and local town residents. They engage in transparent, respectful communication and take a proactive approach to managing their reputation, addressing concerns, and amplifying the positive contributions of their members and peers.

Nominees should highlight specific campaigns, initiatives, or communication strategies used over the past year, along with any outcomes or improvements in visibility, engagement, or public perception that resulted from their efforts.

This award will be reviewed by supporters of the University of Connecticut community from outside the university, please make sure all nominations are fully encompassing of the information that will help reviewers make their decisions.

**Excellence in Risk Mitigation**

This award recognizes a chapter that demonstrates an exceptional and proactive commitment to the health, safety, and well-being of its members and community. The recipient of this award goes beyond simply following policies—they foster a culture of responsible decision-making, shared accountability, and prevention-focused education that empowers members to prioritize safety in all aspects of chapter life.

The winning chapter will have implemented clear, consistent strategies to mitigate risk in areas such as alcohol and drug use, event planning and management, hazing prevention, mental health support, and facility safety. This includes proactive planning, comprehensive member education, and swift action to address concerns or violations. The chapter regularly evaluates its practices, seeks feedback, and works collaboratively with advisors, inter/national organizations, and university staff to ensure a safe and supportive environment for all. This chapter doesn't just manage risk reactively—it builds a culture of care, respect, and accountability that allows members to thrive. Evidence of creative programming, peer-to-peer interventions, and the development of systems or tools (e.g., sober monitor plans, harm-reduction workshops, crisis response protocols) is encouraged.

Nominees should describe specific steps taken over the past year to promote a safer chapter experience, how those efforts were received by members, and the measurable or observable outcomes resulting from those actions.

This award will be reviewed by supporters of the University of Connecticut community from outside the university, please make sure all nominations are fully encompassing of the information that will help reviewers make their decisions.

- Attach proof of a risk meeting/trainings outside of CFSD that helped in your risk mitigation efforts. (UConn PD, Community Standards, Off Campus Activities Advising, National/International Headquarters trainings/meetings etc.)
- Attach all other materials that would support your nomination.

#### **Most Improved Chapter**

This award recognizes a chapter that has demonstrated significant growth and progress over the past academic year. Improvement may be reflected in a variety of areas, including but not limited to chapter operations, academic achievement, community engagement, risk management, member retention, financial stability, leadership development, values alignment, and contributions to diversity, equity, and inclusion.

This chapter has shown a clear commitment to reflection, accountability, and continuous improvement. Through intentional goal setting, meaningful internal changes, and increased engagement with their inter/national organization, university resources, and/or campus community, the chapter has worked to overcome challenges and build a stronger, more sustainable presence.

Nominees should demonstrate measurable outcomes, describe the strategies used to promote improvement, and share how these changes have positively impacted the chapter experience for current and future members.

The Advisors in the Center of Fraternity and Sorority Development will review and consider nominees for this award based on chapter coach advising.

# Individual Award Descriptions

## **Outstanding Advisor**

To acknowledge the outstanding work of advisors, the Center for Fraternity and Sorority Development wishes to recognize those individuals who have been exemplary Advisors over the past calendar year. The *Outstanding Advisor* will be chosen based on their involvement and influence in the organization and the fraternity and sorority community. This advisor is crucial to the success of the chapter and acts as a concrete support system that members could not only rely on, but also learn from.

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

## **Outstanding Chapter President**

The purpose of this award is to recognize the contributions, dedication and hard work of fraternity and sorority chapter presidents who served the community during the last calendar year. This individual should have demonstrated exceptional leadership, character, ability to overcome adversity, and the highest values of their fraternity/sorority. They upheld all their responsibilities as chapter president and went above and beyond to not only ensure the success of their chapter, but also to leave a positive impact on the community. For this award there will be one winner from each council.

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

## **Outstanding Council Officer**

The purpose of this award is to recognize the contributions, dedication, and hard work of members of the community who served on a council in the last calendar year. This officer made great contributions to the council not only through their ability to delegate and make crucial decisions, but also by acting as the glue that keeps the council together.

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

## **Outstanding Scholar**

This award recognizes a student who exemplifies the true spirit of scholarship through both academic excellence and meaningful engagement across campus. Nominees must be among the highest-achieving students within their chapter, as demonstrated by their cumulative GPA, which must be included in the nomination and will be verified by the Center for Fraternity & Sorority Development (CFSD).

In addition to outstanding academic performance, the nominee should demonstrate a strong commitment to leadership, involvement, and service within the fraternity and sorority community, as well as the broader campus. This includes—but is not limited to—leadership roles in student organizations, campus initiatives, research, community outreach, and involvement in programs that promote learning and development beyond the classroom. One student will be selected who not only excels academically but also serves as a role model

and actively contributes to creating a vibrant, engaged, and intellectually curious fraternity and sorority community.

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

### **Emerging Leader of the Year**

The purpose of this award is to recognize outstanding newer members of the fraternity and sorority community who are viewed as emerging leaders. This member has taken the initiative to take on leadership roles and responsibilities to better the organization and leave a positive impact on the Greek community. **Only members initiated in 2025 calendar year are eligible for this award.**

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

- Attach all other materials that would support your nomination.

### **Fraternity and Sorority Member of the Year**

The purpose of this award is to recognize an outstanding member of the fraternity and sorority life community who are viewed as involved, outstanding leaders for both their council and chapter. This member has made an impact of UConn Community along with the Fraternity and Sorority community throughout their membership in their organization. **Only Junior or Senior members are eligible for this award.**

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.

### **Campus Partner of the Year**

The purpose of this award is to recognize the work of a campus partner that helps elevate the UConn Fraternity and Sorority Life Community. This partner goes above and beyond to connect with students, advocates to enhance the mission of the community.

The Advisors in the Center of Fraternity and Sorority Development will review and choose the winner for this award.
